RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

THIS SECTION MUST BE CAREFULLY READ AND SIGNED BY THE APPLICANT

AS CONSIDERATION FOR BEING PERMITTED TO ENTER FOR ANY PURPOSE ANY RESTRICTED AREA (herein defined as including but not limited to racing surface, pit areas, infield, paddock area, grandstand area, and all walkways, concessions and other areas appurtenant to any area where any activity related to the EVENT(S) shall take place), or being permitted to compete, officiate, observe, work for, or for any purpose participate in any way in the EVENT(S), APPLICANT, for himself/herself, Applicant's personal representatives, heirs, and next of kin, acknowledges, agrees and represents that Applicant has, or will immediately upon entering any of such restricted areas, and will continuously thereafter, inspect such restricted areas and all portions thereof which Applicant enters and with which Applicant comes in contact, and Applicant does further warrant that Applicant's entry upon such restricted area or areas and Applicant's participation, if any, in the EVENT(S) constitutes an acknowledgement that Applicant has inspected such restricted areas and that Applicant finds and accepts the same as being safe and reasonably suited for the purpose of Applicant's use, and Applicant further agrees and warrants that if, at any time, Applicant is in or about restricted areas and Applicant feels anything to be unsafe, Applicant will immediately advise the officials of such and will refuse to participate further in the events, and will leave the restricted areas:

1. HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE EAMS, the promoter, participants, any other participating racing association, any sanctioning organization or any subdivision thereof, track operators, officials, vehicle owners, drivers, pit crews, any person in any restricted area, promoters, sponsors, advertisers, owners and lessees of premises used to conduct the EVENT(S) and each of them, their officers and employees, all for the purposes herein referred to as "Releasees", from all liability to the Applicant, Applicant's personal representatives, assigns, heirs, and next of kin for any and all loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the Applicant, whether caused by negligence of the "Releasees", or otherwise while the undersigned is in or upon the restricted area and/or while competing, officiating in, observing, working for, or for any purpose participating in the EVENT(S).

2. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the "Releasees" and each of them for any loss, liability, damage, or cost they may incur due to the presence of the Applicant in or upon the restricted area or in any way competing, officiating, observing, or working for, or for any purpose participating in the EVENT(S) and whether caused by negligence of the "Releasees" or otherwise.

3. HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE due to the negligence of "Releasees" or otherwise while in or upon the restricted area and/or while competing, officiating, observing, or working for or for any purpose participating in the EVENT(S). The Applicant also expressly acknowledges that injuries received may be compounded or increased by negligent rescue operations or procedures of the "Releasees" and assumes all responsibility for such compounded injuries.

APPLICANT expressly acknowledges and agrees that the activities of the EVENT(S) are very dangerous and involve the risk of serious injury and/or death and/or property damage and that Applicant's heirs and next of kin have been so advised. APPLICANT further expressly agrees that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by law of the Province or State in which the EVENT(S) is conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect. The Applicant acknowledges that Applicant has been advised that auto racing is a dangerous activity and has so advised Applicant's next of kin.
